NOTICE OF INTENTION TO MAKE AN ORDER DECLARING
COMPULSORY STANDARDS

NOTICE is hereby given in accordance with section 18(2) of the Standards Act, Chap. 82:03, that the Minister of Trade and Industry, on the recommendation of the Trinidad and Tobago Bureau of Standards, intends to make an Order declaring the standards listed in the Second Column of the Schedule as compulsory standards, with effect from 30th October, 2009 for the purposes specified in the Third Column of the Schedule:
